

## LAST WILL AND TESTAMENT

OF

I, DORIS J. KIICK, residing in the County of Miami-Dade, State of Florida, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking all Wills and Codicils heretofore made by me.

FIRST: I am married to FRANK E. KIICK. I have one children by brings who is known as FRANK JUDE KIICK.

SECOND: I direct that all my debts (other than any mortgage or other secured indebtedness) and funeral and administration expenses be paid out of my estate as soon after my death as convenient. This Article shall not apply to any of my debts that shall be barred for any reason and shall not in any way alter the requirements concerning the presentation of claims during the administration of my estate.

THIRD: I direct that all estate, inheritance, legacy, succession, transfer and other death taxes, including any interest and penalties thereon, imposed by the United States or any state or subdivision thereof, with respect to all property taxable under the laws of such governments or subdivisions by reason of my death, whether or not such property passes under this my Will or any codicil hereto and whether such taxes shall be payable by my estate or by any recipient of such property, shall be paid by my Personal Representative out of my Residuary Estate without apportionment under Section 733.817 of the Florida Statutes, or as may be required by any other law.

If my spouse, FRANK E. KIICK, does not survive me, I direct that this gift shall lapse and shall be disposed of a part of my Residuary Estate.

SIXTH: All the rest, residue and remainder of my estate, wherever situated (herein called my "Residuary Estate"), I give to my son, FRANK JUDE KIICK, if he survives me. If he does not survive me, I give my Residuary Estate to his issue, if any, who survive me, per stirpes.

SEVENTH: If any individual under the age of twenty-five (25) years becomes entitled to a share of my estate on my death, my Personal Representative is authorized and empowered, in his sole and absolute discretion, to transfer and pay over such individual's share, or any portion thereof, without bond, to the guardian of the person or property of such individual, to a custodian to be selected by my Personal Representative under the applicable Uniform Gifts or Transfers to Minors Act, to the person with whom such individual resides to be used for the benefit of such individual, or to such individual if such individual has then reached the age of majority; or my Personal Representative may apply the same for the benefit of such individual. Any portion or all of such individual's share which is not transferred, paid over or applied as provided in the foregoing sentence shall vest in my Trustee, IN TRUST, for the following uses and purposes: to manage, invest and reinvest the same, to collect the income thereof and to apply the net income and principal thereof for such individual's care, support, maintenance, education and general welfare, or accumulate the same, until such individual reaches the age of twenty-five (25) years, to such extent and at such time or times and in such manner as my Trustee, in his sole and absolute discretion, deems advisable. Any net income or principal which my Trustee may determine to so apply may be directly applied or may be paid over, without bond, to such individual as an allowance, to the guardian of the person or property of such individual, to the person with whom such individual resides to be used for the benefit of such individual, or to a custodian to be selected by my Trustee under the applicable Uniform Gifts or Transfers to Minors Act, which custodian may be my Trustee. Any net income not so applied shall be added to the principal of the trust, at least annually, and thereafter shall be held, administered and disposed of as a part thereof. When such individual reaches the age of twenty-five (25) years, any property then remaining in the hands of my Trustee shall be transferred and paid over to such individual, outright and free of trust. If such individual shall die before reaching the age of twenty-five (25) years, the property then

remaining in the hands of my Trustee shall be transferred and paid over to the estate of such individual.

If any tangible personal property shall at any time be held as part of an individual's trust under this Article of my Will, my Trustee shall have no duty to convert the same into productive property, and the expenses of safekeeping thereof, including insurance, shall be a proper charge against the assets of the trust.

If my Trustee, in the exercise of his sole and absolute discretion, shall at any time determine to terminate the trust, full power and authority is given to transfer and pay over the trust property, without bond, to the guardian of the person or property of the individual for whom the trust was created, to a custodian to be selected by my Trustee under the applicable Uniform Gifts or Transfers to Minors Act, or to such individual if such individual has reached the age of majority.

Any Trustee at any time acting hereunder shall have the right to resign by an instrument in writing signed and acknowledged, provided, however, that the resignation of any Trustee acting alone hereunder shall be effective only upon the acceptance of a successor Trustee.

TENTH: Subject to the appointment of fiduciaries provided for under this Will, I authorize the then serving Personal Representative(s) and/or Trustee(s) named under this Will or appointed pursuant to this paragraph to appoint, by an acknowledged written instrument, one or more successors to act as Personal Representative and/or Trustee in his place and/or a Co-Personal Representative and/or Co-Trustee to serve with him. This power to appoint shall be a continuing power which may be exercised any number of times.
