Donna Marie Gonzalez owns only a portion of the North 1/2 of Lot 2, measuring 38.33' x 92.25'. This ownership originates from the Escheatment Tax Deed, which includes that portion along with the South 1/2 of Lots 1 and 2. While the County Deed recorded at Instrument No. 2019000057325 is missing a call, it still encompasses the 38.33' x 92.25' area. As a result, the City of Fort Myers did not hold title to the entire parcel they attempted to convey to Donna Marie Gonzalez.

Mark Nestor is included as an apparent titleholder because he still owns, and has never conveyed, the North 1/2 of Lot 1 and the East 11.67 feet of the North 1/2 of Lot 2.

The legal description included in this report covers the North 1/2 of Lots 1 and 2, along with the associated metes and bounds. However, we have excluded the North 5 feet of Lot 2, as referenced in the original deed recorded at 4093-4391. This portion does not appear in subsequent deeds and was never conveyed to Mark Nestor, and should not be considered part of the current legal description.
